# 10 The Ohio Constitution

The Ohio Constitution is the fundamental law of Ohio. The Constitution defines what rights are guaranteed to Ohio citizens and organizes the government into three separate branches: legislative, executive and judicial. The first Constitution was adopted in 1802 as a prerequisite to statehood. The current Constitution, which dates from 1851 (as amended), is the second in the state's history.

## ORGANIZATION

---

The Ohio Constitution is organized into a preamble and 17 numbered articles. The articles are grouped into seven broad categories: Bill of Rights; framework of government; suffrage and elections; state functions; taxing, borrowing and spending; local government; and amendments.

### GUIDES AND HANDBOOKS

#### **Ohio Constitution Handbook (KFO 401 1851 A6S95)**

Includes an introduction to Ohio Constitutional history, extensive commentary and notes on decisions and opinions for each article and section of the constitution, practice and study aids and a quick reference index.

#### **Ohio Legal Research Guide (KFO 75 P88)**

Comprehensive reference work on every aspect of Ohio legal research. A detailed chapter on the Ohio Constitution includes information about the methods of amending the Constitution, publication of the Constitution, the constitutional history of Ohio and documents of constitutional revision in Ohio.

#### **Ohio State Constitution: A Reference Guide (KFO 401 1851 A6S74)**

Research guide to the text and interpretation of the Ohio Constitution. A section-by-section commentary explains each provision and traces its origins and interpretation by the courts and other government bodies. Includes a detailed chapter on the constitutional history of Ohio, a bibliographical essay, a selected bibliography, a table of cases and a subject index.

### HISTORICAL RESEARCH

---

The Supreme Court Law Library has an extensive collection of primary and secondary materials, including historical codes; session laws; superseded statutes and court rules; treatises; early Ohio reporters; and selected journals, debates and proceedings of the 1802, 1851, 1873 and 1912 constitutional conventions, which are helpful for researching the history of the Ohio Constitution.

#### **The History of Ohio Law (KFO 78 H57)**

Two-volume set containing a collection of essays by academic lawyers, historians and practitioners. Includes essays on Ohio's constitutional conventions and constitutions and Ohio's constitutional culture, a foreword by Chief Justice Thomas J. Moyer, bibliographical references and a subject index.

#### **Ohio Constitutional Revision Commission (KFO 401 1851 A182)**

Ten-volume set published by the Ohio Constitutional Revision Commission, which was organized from 1970 to 1977, to study the Ohio Constitution and recommend necessary changes to the Ohio General Assembly.

#### **Proceedings and Debates of the Constitutional Convention of the State of Ohio - 1912**

Available on the Court's Web site, these documents include word-for-word accounts of delegate discussion during 22 weeks of meetings.
