In accord with the emergency orders issued by Charlotte Coleman Eufinger, Judge of the Union County Common Pleas Court, Probate and Juvenile Divisions, beginning March 16, 2020, and in acknowledgment and upon consideration of Executive Order 2020-01D issued March 9, 2020 by Hon, Mike DeWine, Governor of the State of Ohio and Declaring a State of Emergency as the result of Coronavirus Disease 2019.

IT IS HEREBY ORDERED that to protect the health of our citizens and of Court employees, the Union County Probate and Juvenile Court shall remain open to the public for court business only. Anyone without specific business in the Courthouse is discouraged from visiting.

The public is welcome to call the Court at (937) 645-3029 for guidance, if desired. Probate and Juvenile Court staff will be available by telephone and email, mail will be received, and clerks' offices will remain open to receive filings.

IT IS FURTHER ORDERED that all individuals seeking entry to the Courthouse shall check in with security at the security station; comply with all directives of the deputy at the security station; provide proper identification; sign in with name, address and contact information; answer all questions propounded; have their temperature taken; and follow security directives regarding the metal detector. Anyone who exhibits signs of illness shall be prohibited from entering. All individuals who are permitted entry into the Courthouse shall practice social distancing and shall attempt, whenever possible, to keep a distance between themselves and others of 6 feet or more.

IT IS FURTHER ORDERED that this order shall not apply to Union County employees.


