Decision of Magistrate

This matter came to be heard on a Motion to Declare Father, Nathaniyah Yisrael, a Vexatious Litigator. The motion was filed on September 2, 2021 by Angela Saturday, guardian of mother Camille Jones. Father was served by the Sherriff of Hamilton County on 9/07/2021. Ms. Saturday is represented by Gerald Greene. Father was not present for the hearing. Trial was held on 1/11/2022 in Courtroom 609. This matter was filed pursuant ORC 2151.23(A) (2), and ORC 2323.52.

FINDINGS OF FACT and CONCLUSIONS OF LAW

This matter was presented by Counsel for the Guardian of mother. Counsel presented Exhibits 1 through 18. These Exhibits represent the filings of Father with this Court. The Court will now admit Exhibit 1 excluding the first page which is movant's motion herein. The Court takes judicial notice of the remaining pages of Exhibit 1 as Court filings and Court orders, Decisions, and Judicial Entries. The Court takes judicial notice of all the remaining Exhibits as the Court filings except Exhibit 9, 12, 14, 16, 17, and 18 which are not filings by Father or are not the filings in this Court. The Court also finds that the Exhibits admitted herein are in compliance with Evidence Rule 901 (B) (7). The Exhibits from the Court of Appeals are not certified. This matter was presented as a default matter due to Father failing to appear.

DECISION

Ohio Revised Code 2323.52 requires a showing that the filings by Mr. Yisrael are filed as a means to harass Ms. Saturday, mother' guardian. Further, the filings are not supported by existing law or cannot be supported by a good faith argument to modify, reverse, or extend existing law.

Mr. Yisrael has habitually filed pleadings and motions that are not supported by any reasonable grounds or case law. An example in Exhibit 13 Father challenged the Court's jurisdiction as to the support issue related to the child. He then appears for the hearing and will not answer questions. Clearly the only thing that the Magistrate could do is dismiss his motion. He requested a dismissal under the "British Accredited Registry ". The argument is nonsensical. The matter was dismissed on 12/09/2019. Exhibit 15 shows that Father then filed another motion to dismiss on the same grounds on 2/12/2021. The remaining Exhibits contain numerous examples of violations by Father of the statute. Exhibit 1 contains the Court's orders an Decision where Father was found to have obstructed the court process during the trial as to custody. Father was given ample opportunity to present sensible and legally supported arguments as to the legal issue in all of his motions. Father chose to present nonsense. Father's motions rarely if at all contained reasonable grounds in these civil actions.

Based upon the evidence presented the Court finds that Father, Nethaniyah Yisrael, is a vexatious litigator. Therefore pursuant to ORC 2323.52 Father is prohibited from instituting legal

proceedings in Hamilton County Juvenile Court without first obtaining leave of the Court as set forth under ORC 2323.52 (F) (1). This Decision shall be indefinite as set forth under section (E). This matter is to entered an appropriate notice shall be given to the Clerk of this Court so they ar aware of requirements as to Father filing any motions with their office.
