MOTION AND PROCEDURAL RULINGS

2007-1863. Middleburg Hts. v. Quinones.

Cuyahoga App. No. 88242, 2007-Ohio-3643. This cause is pending before the court as an appeal from the Court of Appeals for Cuyahoga County. Upon consideration of the motion of appellant and amici curiae to supplement the record, It is ordered by the court that the motion is denied.

DISCIPLINARY CASES

2008-0455. In re Resignation of Bowen.

On affidavit of resignation from the practice of law of John Wesley Edward Bowen, Attorney Registration No. 0001899, and on report filed under seal by Disciplinary Counsel. Resignation accepted with disciplinary action pending.

MISCELLANEOUS DISMISSALS

2007-2335. Harris v. Used Car Ctr., Inc.

Butler App. No. CA2007-09-205. This cause is pending before the court as a discretionary appeal and claimed appeal of right. Upon consideration of appellants' application for dismissal,

It is ordered by the court that the application for dismissal is granted. Accordingly, this cause is dismissed.

2007-2456. State v. Bibbs.

Clark App. No. 06-CA-119, 2007-Ohio-5565. This cause is pending before the court as a discretionary appeal and claimed appeal of right. It appears from the records of the court that the appellant has not filed a memorandum in support of

jurisdiction, due March 21, 2007, in compliance with the Rules of Practice of the Supreme Court and therefore has failed to prosecute this cause with the requisite diligence. Upon consideration thereof,

It is ordered by the court that this cause is dismissed sua sponte.

MISCELLANEOUS ORDERS

ORDER

This matter originated in this court on the filing of a report by the Commission on Continuing Legal Education (the "commission") pursuant to Gov.Bar R. X(6)(A)(1)(b) and (2)(d). The commission recommended the imposition of sanctions against certain attorneys and judges, including the above-named respondent, for failure to comply with the applicable continuing legal education provisions of Gov.Bar R. X and Gov.Jud.R. IV for the 2005-2006 reporting period.

On January 25, 2008, pursuant to Gov.Bar R. X(6)(B)(1), this court issued to the respondent an order to show cause why the recommended sanction should not be adopted by the court and an order so entered against the respondent. Pursuant to the order to show cause, respondent has tendered payment in the amount of the recommended sanction, in lieu of filing objections. Upon consideration thereof,

It is ordered by the court that the sanction of \$[sanction amount] is hereby imposed upon the respondent and payment of the sanction is acknowledged.

It is further ordered by the court that this order shall not be considered a disciplinary order pursuant to Gov.Bar R. V or Gov.Bar R. X(6)(H).

It is further ordered that service shall be deemed made on respondent by sending this order, and all other orders in this case, by certified mail to the most recent address respondent has given to the Office of Attorney Services.

It is further ordered that payment of the sanction notwithstanding, respondent shall comply with the requirements imposed by Gov.Bar R. X for the 2005-2006 reporting period. See CLE Reg. 503.4.
